- Statement of Bank account for the last 6 months of borrower (s).
- Signature Identification from bankers of borrower(s)/guarantor(s).
- A copy of Passport/ Voter's ID Card/ Proof of residence.
- Statement of Assets & Liabilities of borrower(s).
- Proof of income:
 - For salaried persons: employment details for last 5 years, latest salary slip showing all deductions & latest TDS certificate [Form 16]
 - For self-employed/ professionals & businessmen: IT Returns for 2/3 years duly acknowledged by the ITO if assessment
